1. Technical description of the product

The TOX Liquix Plus 7, Liquix Plus 7 Desert, Liquix Plus 7 Snow polyester resin styrene-free for non-cracked concrete is a bonded anchor consisting of a cartridge with injection mortar and a steel element. The steel elements consists of a commercial threaded rod, a hexagon nut and a washer. The steel elements are made of galvanized steel or stainless steel.

The steel element is placed into a drilled hole filled with injection mortar and is anchored via the bond between metal part, injection mortar and concrete.

The illustration and the description of the product are given in Annex A.

2. Specification of the intended use in accordance with the applicable EAD

The performances given in Section 3 are only valid if the anchor is used in compliance with the specifications and conditions given in Annex B.

The provisions made in this European Technical Assessment are based on an assumed working life of the anchor of 50 years. The indications given on the working life cannot be interpreted as a guarantee given by the producer, but are to be regarded only as a means for choosing the products in relation to the expected economically reasonable working life of the works.

3. Performance of the product and references to the methods used for its assessment

5. Technical details necessary for the implementation of the AVCP system, as provided in the applicable EAD

5.1 Tasks of the manufacturer

The manufacturer shall exercise permanent internal control of production. All the elements, requirements and provisions adopted by the manufacturer shall be documented in a systematic manner in the form of written policies and procedures, including records of results performed. This production control system shall insure that the product is in conformity with this European Technical Assessment.

The manufacturer may only use raw materials stated in the technical documentation of this European Technical Assessment.

The factory production control shall be in accordance with the control plan which is a part of the technical documentation of this European Technical Assessment. The control plan is laid down in the context of the factory production control system operated by the manufacturer and deposited at Technický a zkušební ústav stavební Praha, s.p.² The results of factory production control shall be recorded and evaluated in accordance with the provisions of the control plan.

The manufacturer shall, on the basis of a contract, involve a body which is notified for the tasks referred to in section 4 in the field of anchors in order to undertake the actions laid down in section 5.2. For this purpose, the control plan referred to in this section and section 5.2 shall be handed over by the manufacturer to the notified body involved.

The manufacturer shall make a declaration of performance, stating that the construction product is in conformity with the provisions of this European Technical Assessment.

The control plan is a confidential part of the documentation of the European Technical Assessment, but not published together with the ETA and only handed over to the approved body involved in the procedure of AVCP.

5.2 Tasks of the notified bodies

The notified body shall retain the essential points of its actions referred to above and state the results obtained and conclusions drawn in a written report.


The notified certification body involved by the manufacturer shall issue a certificate of constancy of performance of the product stating the conformity with the provisions of this European Technical assessment.

Anchorages subject to:

Static and quasi-static loads: M8 to M24.

Base materials:

- Reinforced or unreinforced normal weight concrete according to EN 206-1:2000.
- Strength classes C20/25 to C50/60 according to EN 206-1:2000.
- Non-cracked concrete: M8 to M24

Temperature range:

- I: 40 °C to +40 °C (max long term temperature +24 °C and max short term temperature +40 °C)
- II: 40 °C to +80 °C (max long term temperature +50 °C and max short term temperature +80 °C)

Use conditions (Environmental conditions):

- Structures subject to dry internal conditions (zinc coated steel, stainless steel or high corrosion resistant steel).
- Structures subject to external atmospheric exposure (including industrial and marine environment) and to permanently damp internal condition, if no particular aggressive conditions exist (stainless steel or high corrosion resistant steel).
- Structures subject to external atmospheric exposure and to permanently damp internal condition, if other particular aggressive conditions exist (high corrosion resistant steel).

Note: Particular aggressive conditions are e.g. permanent, alternating immersion in seawater or the splash zone of seawater, chloride atmosphere of indoor swimming pools or atmosphere with extreme chemical pollution (e.g. in desulphurization plants or road tunnels where de-icing materials are used).

Design:

- Verifiable calculation notes and drawings are prepared taking account of the loads to be anchored. The position of the anchor is indicated on the design drawings (e. g. position of the anchor relative to reinforcement or to supports, etc.).





Assembly instructions



1 Drill with hammer drill a hole into the base material to the size and embedment depth required by the selected anchor (Table B1). In case of aborted drill hole: the drill hole shall be filled with mortar.



Attention! Standing water in the bore hole must be removed before cleaning.

2a Starting from the bottom or back of the bore hole, blow the hole clean with oil-free compressed air (min. 6 bar) or a hand pump (Annex B2) a minimum of four times. If the bore hole ground is not reached an extension shall be used.

The hand-pump can be used for anchor sizes up to bore hole diameter 20 mm.



For bore holes larger then 20 mm or deeper 240 mm, oil-free compressed air (min. 6 bar) **must** be used.



2b Check brush diameter (Table B2) and attach the brush to a drilling machine or a battery screwdriver. Brush the hole with an appropriate sized wire brush > db,min (Table B2) a minimum of four times.

If the bore hole ground is not reached with the brush, a brush extension shall be used (Table B2).



2c Finally blow the hole clean again with oil-free compressed air (min. 6 bar) or a hand pump (Annex B2) a minimum of four times. If the bore hole ground is not reached an extension shall be used.

The hand-pump can be used for anchor sizes up to bore holes diameter 20 mm. For bore holes larger than 20 mm or deeper 150 mm, oil-free compressed air (min. 6 bar) <u>must</u> be used.

After cleaning, the bore hole has to be protected against re-contamination in an appropriate way, until dispensing the mortar in the bore hole. If necessary, the cleaning repeated has to be directly before dispensing the mortar. In-flowing water must not contaminate the bore hole again




3. Attach a supplied static-mixing nozzle to the cartridge and load the cartridge into the correct dispensing tool. Cut off the foil tube clip before use.

For every working interruption longer than the recommended working time (Table B3) as well as for new cartridges, a new static-mixer shall be used.



4. Prior to inserting the anchor rod into the filled bore hole, the position of the embedment depth shall be marked on the anchor rods.





 Prior to dispensing into the anchor hole, squeeze out separately a minimum of three full strokes and discard non-uniformly mixed adhesive components until the mortar shows a consistent grey colour. For foil tube cartridges is must be discarded a minimum of six full strokes.





7. Push the threaded rod into the anchor hole while turning slightly to ensure positive distribution of the adhesive until the embedment depth is reached.

The anchor should be free of dirt, grease, oil or other foreign material.

- 8. Be sure that the anchor is fully seated at the bottom of the hole and that excess mortar is visible at the top of the hole. If these requirements are not maintained, the application has to be renewed. For overhead application the anchor rod should be fixed (e.g. wedges).

- 9. Allow the adhesive to cure to the specified time prior to applying any load or torque. Do not move or load the anchor until it is fully cured (attend Table B3).
- 10. After full curing, the add-on part can be installed with the max. torque (Table B1) by using a calibrated torque wrench.
